## 2008 Colorado Ballot Issues



You are encouraged and it is within your legal rights to take this Voter Guide with you into your polling place.

**Amendment 48 - YES:** This is the single most important ballot issue in the entire country for Christians and pro-life citizens. This amendment will finally put into law what we already know from God's Word and modern science - a person is a person at the moment of conception and deserves the same "personhood" rights as the rest of us. Don't fall for the lies of the abortion industry. Please vote your conscience. Choose life!

**Amendment 54 - YES:** Along with Amendment 48, this initiative is vitally important to Christians in Colorado. Right now, the state awards "no-bid" contracts and there is little or no accountability on where our money goes. Over \$400 million of our tax dollars are given to businesses and entities (including some of the state's abortionists!) and they are free to use that money to influence the political system with contributions to candidates and political parties. We need to put a stop to this corrupt loop-hole and 54 will do just that.

**Amendment 46 - YES:** This amendment will go along way toward ending discrimination and preferential treatment by government. We were all created in the image of God and are all equal in His eyes. Shouldn't our laws reflect that truth?

**Amendment 47 - YES:** It is wrong to force someone to pay money in order to have a job and put food on the family table. It is IMMORAL to then take that money and funnel it to unGodly efforts and candidates. This amendment will not ban unions but will simply say that there should not be forced-unionism in Colorado. If someone wants to belong to a union, they will still be able to. If they don't, they won't be forced to.

**Amendment 48 - YES:** Defines a person to include the unborn.

**Amendment 49 - YES:** As with Amendment 47, it is wrong for the government to collect money that is then used for radical special interests. This amendment would not ban any unions but simply make the unions collect their own dues.

**Amendment 50 - NO:** This amendment would allow a massive expansion of gambling here in Colorado. Just like in Las Vegas, the evidence is clear - increased gambling and gambling addictions severely hurt and erode families. Let's work to strengthen the family, not weaken it.

**Amendment 51 - NO:** While it may sound like a good idea on the surface, this amendment is terrible fiscal policy. This \$186 million a year tax increase sidesteps our Taxpayer Bill of Rights and takes budgeting power away from those we elect to represent us at the State Capitol.

**Amendment 52 - YES:** This amendment would take a portion of our taxes and dedicate them to special road projects in Colorado. We must establish a real transportation plan for the state and this no-new-taxes approach is a good start for the future of Colorado.

**Amendments 53, 55, 56, & 57 have been withdrawn from this election:** If they appear on your ballot, there is no need to vote on them as the votes will not be counted.

**Amendment 54 - YES:** See above.

**Amendment 58 - NO:** This amendment is bad for every working family and small business. If the oil and gas industry are forced to pay more taxes, it will only increase the cost of our gas, food, and anything families buy that requires transportation. Our government doesn't need more money - they need to learn to prioritize and spend more wisely.

**Amendment 59 - NO:** This is the biggest tax increase in our state's history. Billed as a method of funding education, it's actually just a financial shell-game so the legislature can spend more in other areas. By making the Referendum C tax increase permanent, this amendment will dismantle the major portion of our Taxpayer Bill of Rights forever. We and our children will pay the price if this amendment passes.

**Referendum L - YES:** This referendum will lower the minimum age to serve in the legislature to 21. In our country, persons who reach the age of 21 are considered adults and there are many examples in other states of individuals below the age of 25 who have served effectively and honorably in their state government.

**Referendum M - YES:** Obsolete provisions in law.

**Referendum N - YES:** Obsolete provisions in law.

**Referendum O - NO:** This amendment will make it much more difficult for citizens to place a question on the ballot. It may sound great on the surface but in reality it will weaken our ability to affect our government when they have proven incapable. Big money interests will benefit from this referendum and grassroots citizen groups will be silenced.

According to IRS regulations, churches may take a complete and unambiguous stance for or against a particular ballot measure. While a church may not officially advocate for the election or defeat of a particular candidate, a church may endorse or denounce any ballot amendment or referendum.
